ENTRY REQUIREMENTS

Applicants for a Master's Programme at UUM, COB must possess:

- A bachelor's degree from Universiti Utara Malaysia or any other institutions of higher learning recognized by the University Senate with a CGPA of at least 2.75; OR
- A bachelor's degree from Universiti Utara Malaysia or any other institutions of higher learning recognized by the University Senate with a CGPA of not less than 2.75, and have at least five (5) years of relevant working experience may be considered, subject to the interview by Postgraduate Committee OR
- A diploma from any institution of higher learning recognized by the University Senate with at least ten (10) years of relevant work experience, 35 years or older and passed APEL assessment (level 7); AND
- Fulfil English language requirement as set by the University Senate.

*NOTE

Applicants who do not meet any of the above postgraduate admission requirements can still be considered for enrolment upon recommendation by the Postgraduate Committee and endorsement by the Senate. Applicant may be required to attend an interview.
